Chair & Quorum

- 1. The meeting commenced at 7:31pm with Bill Boyd as chair.
- 2. The Chair advised the meeting was being recorded and welcomed and thanked attendees for the participation in the meeting. The Chair also welcomed non delegates.
- 3. The Chair announced a quorum present and that the meeting was duly constituted.
- 4. The Chair articulated "Welcome to Country & Acknowledgement of Country".

Apologies

- 5. There were no apologies submitted to the meeting.
- 6. Guess Speaker: Linda Groom on "Reclaim Kosci Campaign"
 The Chair welcomed Linda Groom (winner of the Bushwalking NSW's 2019 Chardon Award) for significant contributions to bushwalking) and her support team and welcomed Linda to address the meeting as the 2020 AGM guest speaker.
- 7. Linda updated the audience on the campaign to address feral horse damage in Australian alpine areas. Linda spoke of the specific areas of damage, the protest walk in 2018, the 2019 petitions, artwork being undertaken in support of the campaign, and horse survival rates after the 2019/2020 bushfires. Linda noted the strong support of the campaign by the NSW Minister for Energy and the Environment, Matt Kean. On political matters Linda also noted the pitch to represent the issue to candidates in the Eden Monaro by-election.

Linda also spoke to the legal actions undertaken by feral horse supporters in Victoria and NSW. In both states the representations were rejected by the courts of those states.

- a. At the conclusion of the guest speakers presentation the Chair opened the meeting to General Business, and moved that we accept the minutes of the previous AGM. In so doing the Chair acknowledged the significant role played by Alex in the position of President and thanked him for the contribution he has made to BNSW.

 - i. It was observed that the brokers fee (insurance) looks like a large percentage of the premium. The observer asked why their fee was not included in the premium.
 - ii. The Treasurer responded by noting he prefers to the fee broken out rather than lost in the overall fee, but was unable to comment on the scale of this fee versus what a standard brokerage fee might look like.

 - a. The Management Committee (MC) has continued to work on the document,

 - c. The document was not quite ready, and
 - d. Asked for patience for one to two months by which he anticipated an EGM would be called to approved the new Constitution.
- 13. The Chair reminded the meeting of the need to amend the document, in particular drawing attention to:
 - a. The need to be current with current laws and statutes
 - b. Be aligned with community expectations about expressions of gender and otherwise be aligned with other social expectations, and
 - c. To reflect changes within the organisation itself, and to therefore reflect how we want to do business.
- 14. The Chair extended an invitation to all to 'one last chance' to have input into the revised Constitution.

15. The Chair spoke to the Strategic Plan work being done and suggested delegates provide input and direction to same.

- 16. The Chair handed over the meeting to Keith Maxwell in his capacity of Returning Officer.
- 17. The Returning Officer declared all positions vacant and open.
- 18. No written nominations were submitted to the meeting for any of the positions declared vacant.
- 19. The Returning Officer invited nominations from the floor for each position filled, sought confirmation of willingness to stand from each nominee, and ensured all nominations were seconded. Second and third calls for each position were made.
